## **CMS Quality Improvement Contract Updates**

Sections of the Social Security Act established the QIO Program to: improve the effectiveness, efficiency, economy, and quality of services delivered to Medicare beneficiaries

### **Programs Over the Years**

- Partnership for Patients, Hospital Engagement Networks (HENs), Hospital Improvement and Innovation Network (HIIN), Hospital Quality Improvement Contractors (HQIC)
- Quality Innovation Network-Quality Improvement Organization (QIN-QIO)

### **Program Changes**

- April 2023 Program Changes Announced: consolidate hospital QI into QIN-QIO; formation of 7 regions
- Compass Healthcare Collaborative and Comagine Health partnership; proposal to CMS submitted September 2024
- Contract awards made late May 2025 to another QIN-QIO

Providers must own the agenda to improve quality and safety in their communities


