In response, new policy initiatives, like the CMS Patient Safety Structural Measure, are increasing the importance of developing highly reliable CRPs. At this session, we will review these emerging developments, discuss the barriers to highly reliable CRP implementation, and identify new tools and resources (including those from IHC) that are available to help healthcare organizations improve their CRP design and operation.
